### **Drug Free Sport Policy**

Applicability	Athlete

#### **Background**

The 2027 World Anti-Doping Code (the Code) was launched in September 2023 by the World Anti-Doping Agency (WADA). The Code is the core document that harmonizes anti-doping policies, rules, and regulations across sport organizations and public authorities around the world. The Code works in conjunction with the International Standards, which collectively foster consistency among anti-doping organizations in various areas.

Whistler Sport Legacies (WSL) is committed to upholding the highest standard of safe and drug free sport and prohibits the possession, sale, consumption, or being under the influence of any listed substances outlined in the Canadian Anti-Doping Document (CADD).

#### **Policy**

Formally documents that WSL has adopted the 2021 CADD as its primary Anti-Doping policy.

### 1.0 Scope and Authority

- This policy applies to all Athletes
- In the event of a conflict between this Policy and the 2021 CADD, the 2021 CADD shall prevail

#### 2.0 Commitment, Adoption and Cooperation

- WSL is committed to clean sport in Canada and endorses the 2021 CADD and the WADC
- WSL has adopted and agrees to abide by the CADP which may be amended from time to
- WSL is unequivocally opposed to the practice of doping in sport on ethical, medical and legal grounds
- WSL Board of Directors has approved the adoption of the CADD
- WSL shall cooperate with the Canadian Centre for Ethics in Sport's (CCES) investigations regarding potential anti-doping rule violations

#### 3.0 Athletes and Athlete Support Personnel

• Per the CADD, an 'Athlete' is any person who competes in the sport at the international level or the national level. The CCES also has the discretion to apply anti-doping rules to an Athlete who is neither an international level Athlete or a national level Athlete and bring them within the definition of 'Athlete'

### **Drug Free Sport Policy**

- Per the CADD, 'Athlete support personnel' are defined as any coach, trainer, manager, agent, team staff, official, medical, paramedical personnel, parent or any other person working with, treating or assisting an Athlete participating in or preparing for sports competition.
- Per the CADD, designated Athlete support personnel are specifically identified by WSL as those individuals who are:
  - a) Working as Athlete support personnel under contract with or under the direct control and/or supervision of WSL; and
  - b) Providing training, treatment and assistance to Athletes preparing for sports competitions at the elite level, which include Athletes, development teams and national team members

#### 4.0 Sanctions and Reciprocity

- WSL will comply with the CADD with respect to public announcements of positive test results
- WSL will respect any penalty enacted pursuant to the breach of the CADD whether it is imposed by WADA or the CCES
- WSL will respect the sanctions applied to an Athlete due to an anti-doping rule violation, whether imposed by WADA, the CCES, or any national or provincial sport organization
- All Athletes sanctioned for an anti-doping rule violation will be ineligible to participate in any
  role with WSL or in any competition or activity organized, convened, held, or sanctioned by
  WSL as per the penalties imposed
